Governor Hogan Announces End of COVID-19 State of Emergency

Governor Hogan announced the end of the COVID-19 state of emergency in the State of Maryland effective July 1. The COVID-19 state of emergency will end in two phases:

Emergency Mandates And Restrictions End on July 1

All emergency mandates and restrictions will be terminated as of July 1. There will no longer be any statewide mask order in effect for any settings, including schools, camps, and child care facilities.

45-Day Administrative Grace Period Through August 15

Thursday, July 1 will mark the beginning of a 45-day grace period, where certain regulations will continue to be relaxed to complete the administrative transition out of the pandemic. This includes such provisions as renewing driver's licenses, winding down emergency health operations, and the moratorium on evictions related to COVID-19.

Impact on Alcohol To-Go (Carryout/Delivery)

The current Executive Order allowing alcohol to-go (carryout/delivery) will also end on July 1st

(for licenses that did not already include such off-sale privileges prior to the related Executive Order). However, local liquor boards may adopt related regulations/registration process to allow such privileges to continue in the local jurisdiction until June 30, 2023, as authorized by House Bill 12/Senate Bill 205.

If your business/customers benefited from such privileges during the pandemic and would like for this to continue, NOW is the time to contact Worcester County Liquor Board requesting that they adopt related regulations as soon as possible. The Restaurant Association of Maryland and the Maryland Licensed Beverage Association have already sent a Letter to Local Liquor Boards requesting such. But it's important for local liquor boards to also hear directly from licensees on this issue. If this continued privilege will be helpful to your business on our long road to recovery, please contact Worcester County Liquor Board now!
