## Governor Hogan Announced New Vaccination Protocols for All Nursing Home and Hospital Staff

Employees of Maryland nursing homes and Maryland hospitals will need to receive their first dose of a COVID-19 vaccine by September 1.

Governor Hogan also called on federal administration to take the following actions:

- Make Booster Shots Available Immediately For Seniors And Vulnerable
  Populations
- Advance Full FDA Approval Of Vaccines. Full approval would be a significant boost to the state's vaccine distribution operation
- Expedite Approval of Vaccines For 5- To 11-Year-Olds

The Governor is also launching a new statewide antibody testing program for nursing home residents to ascertain their levels of immunity.

The Treasury Department and the IRS issued further <u>guidance on the Employee Retention</u> <u>Credit</u>. They also issued a <u>safe harbor allowing employers to exclude certain items from</u> <u>their gross receipts</u> solely for determining eligibility for the Employee Retention Credit.
