Special Event Zone in Ocean City Through Sept. 26



In anticipation of the unsanctioned pop-up car rally, Ocean City has established a Special Event Zone that will be in place through September 26, intended to help deter dangerous driving and motor violations by lowering speed limits and increasing fines and penalties. Significant traffic congestion, alternate traffic patterns, a high volume of pedestrians and a heavy police presence is anticipated throughout the weekend. Similar to a Construction Zone, violators of the Special Event Zone will face increased fines, or in some cases arrest.

Town of Ocean City Alerts to Virtual Hearings on September 28 & 30 Hosted by the Public Service Commission on Offshore Wind Projects

Our 10 mile, beautifully maintained beach and three-mile historic Boardwalk often rank among the nation's top beaches, offering families like yours the perfect place to relax and enjoy the naturally beautiful view of the Atlantic Ocean. Unfortunately, our natural viewshed is in danger

of being changed forever.

As you may or may not know, two companies are planning to build offshore wind farms directly off of Delaware and Maryland beaches. This project will forever change the natural beauty of our beach, not only for us but for future generations. These companies are now proposing to expand these projects to add over 150 turbines beyond what has already been approved. One company, US Wind, proposes to construct 104 turbines as close as 13 miles from our beach.

Other states have taken steps to protect their coastal communities from the harmful visual impact of these projects. For example:

- New York requires that these giant turbines be at least 20 miles from shore
- Virginia's closest turbines are 27 miles from shore.
- The Kitty Hawk project off the North Carolina Outer Banks closest turbines are 30 miles from shore.

We think Maryland should do the same by requiring that these supersized offshore wind turbines be at least 30 miles from our coast. This distance would allow the project to continue without having any impact on our viewshed, our tourism, our home values, our economy and future generations.

The Maryland Public Service Commission will hold two virtual public comment hearings on the applications submitted by two offshore wind developers under Maryland's Clean Energy Jobs Act of 2019 (CEJA). The CEJA provisions called for an additional 1,200 MW of offshore wind generation in order to meet Maryland's clean energy goals.

The hearings will be held on Tuesday, September 28 and Thursday, September 30, 2021, each beginning at 6pm. Members of the public who wish to comment should send an email by **noon TODAY, Friday, September 24** to susan.howard@maryland.gov. Participants should indicate which day they would like to speak and will receive a link to the WebEx platform to join that day's hearing. The hearings will also be livestreamed.
